WHEREAS, Communication 14-C-5087 by Mayor Kasim Reed appointing Michele Taylor to the Midtown Community Improvement District (CID) Board of Directors was “filed” by the Atlanta City Council on September 15, 2014; and

WHEREAS, the “filed” action of Council indicates no objection to the appointment, however based on the State of Georgia Community Improvement Act, the appointee serves at the pleasure of the Council; and

WHEREAS the standard method for the Council to indicate its pleasure regarding the appointment is to affirmatively “confirm”; and

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA that Mayor Kasim Reed’s appointment of Michele Taylor to the Midtown Community Improvement District (CID) Board of Directors is hereby “confirmed” by the Atlanta City Council with such confirmation being effective for a term of four (4) years to begin on September 15, 2014 and expire on September 15, 2018.
