NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, the Chief Procurement Officer or his designee, in consultation with the City Attorney or her designee, is directed to prepare a new sole source agreement, to be designated as FC-8933, and any other requisite documentation for execution by the Mayor or his designee for the purchase of case management system maintenance and support services provided by CJS, on behalf of the Municipal Court.

BE IT FURTHER RESOLVED, that said agreement number FC-8933 is for a term not to exceed one (1) year, effective July 1, 2016 in an amount not to exceed Two Hundred Twenty-One Thousand One Hundred Thirty-One Dollars and Zero Cents (\$221,131.00).

 - a. The Limits of Insurance provided to you in this policy; or

2. We receive written notice of a claim or “suit“ as soon as practicable; and
3. A request for defense and indemnity of the claim or “suit“ will promptly be brought against any policy issued by another insurer under which the additional insured may be an insured in any capacity.
