A RESOLUTION TO ERECT A HISTORICAL MARKER AT THE CASCADE NATURE PRESERVE TO COMMEMORATE THE BATTLE OF UTOY CREEK; AND FOR OTHER PURPOSES.

WHEREAS, the Battle of Utoy Creek was fought August 4-7, 1864, during the Atlanta Campaign of the American Civil War; and

WHEREAS, Major General William T. Sherman's Union armies partially encircled the City of Atlanta, which was being held by Confederate forces under the command of General John Bell Hood; and

WHEREAS, the Cascade Springs Nature Preserve (the "Nature Preserve") is a 120-acre preserve located on Cascade Road in Southwest Atlanta, purchased by the City in the 1970s and contains extensive trails, wildlife, and outdoor auditorium; and

WHEREAS, the Nature Preserve contains remnants of the Confederate earthworks and is the site of the deaths of hundreds of soldiers as part of the Battle of Utoy Creek; and

WHEREAS, it is in the best interest of the City to place a Historical Marker at the Cascade Nature Preserve to commemorate the Battle of Utoy Creek that was fought on the site

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES, that the Mayor, or his designee, is hereby authorized to place a historical marker at the Cascade Nature Preserve to commemorate the Battle of Utoy Creek.

BE IT FURTHER RESOLVED, that all resolutions or parts of resolutions in conflict herewith are hereby waived to the extent of the conflict.
