A RESOLUTION AUTHORIZING THE MAYOR, ON BEHALF OF THE CITY, TO ACCEPT A DONATION FROM THE AMERICAN RED CROSS AS PART OF THE PILLOWCASE PROJECT AT VARIOUS CITY OF ATLANTA RECREATION CENTERS; AND FOR OTHER PURPOSES.

WHEREAS, the Post 1 At-Large Councilmember has partnered with the American Red Cross, Atlanta Fire & Rescue, and the Atlanta Police Department to educate youth across the City on disaster preparedness; and

WHEREAS, the American Red Cross' Pillowcase Project is an hour-long preparedness education program for children in grades 3 – 5, which teaches students about personal and family preparedness, local hazards, and basic coping skills; and

WHEREAS, the Pillowcase Project will begin at various Recreation Centers, in conjunction with Camp Best Friends, across the City beginning July 7, 2016; and

WHEREAS, participating children will also learn about home fires and how to create an evacuation plan; and

WHEREAS, the City is appreciate of the men and women of Atlanta Fire & Rescue and the generosity of the American Red Cross to provide these donated items as part of the Pillowcase Project.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES, that the Mayor, on behalf of the City of Atlanta, is hereby authorized to accept a donation of the American Red Cross as part of the Pillowcase Project, to be conducted at various City recreation centers beginning the week of July 7, 2016.

BE IT FINALLY RESOLVED, that to the extent that the American Red Cross is donating time and resources to the City, the City hereby accepts the donation.
