

**A CORRECTIVE ORDINANCE
BY COUNCIL MEMBER ANDRE DICKENS**

**AN ORDINANCE TO CORRECT AND CLARIFY CERTAIN
REFERENCES WITHIN ORDINANCE
14 -O-1379 TO NOW AMEND ATLANTA CITY CODE OF
ORDINANCES DIVISION 9 YOUTH COMMISSION SECTION 2-2128
GOVERNING BOARD COMPOSITION; AND FOR OTHER PURPOSES**

WHEREAS, Ordinance 14-O-1379 was adopted on the Atlanta City Council on August 18, 2014; and

WHEREAS, it has since been determined that clarification and correction is needed regarding Ordinance 14-O-1379; and

WHEREAS Ordinance 14-O-1379 incorrectly referenced City Code Section 2-5052 which was taken from the City's 1977 Code of Ordinances and should have been taken from the 1995 Code of Ordinances; and

WHEREAS Ordinance 14-O-1379 should have referenced **Atlanta City Code of Ordinances Division 9 Youth Commission Section 2-2128** of the 1995 Code of Ordinances currently in use; and

WHEREAS Ordinance 14-O-1379 requires clarification regarding the Mayor's appointments and the City Council related appointments, correction regarding naming the Atlanta Board of Education instead of the Atlanta Public Schools and the deletion of the Atlanta Project which is no longer an active organization in the City.

NOW, THEREFORE, BE IT ORDAINED that the Atlanta City Code of Ordinances Division 9 Youth Commission Section 2-2128 Governing Board Composition, shall read as follows:

The Governing Board shall be composed of residents of the City of Atlanta with a total membership not to exceed fifteen (15) members to serve two-year terms each. The members shall be selected as follows:

Six (6) members appointed by the Mayor :

- 1) The Chief of Police or his/her designee,

- 2) The Commissioner of the Department of Parks & Recreation or his/her designee,
- 3) Two youth members nominated by the Superintendent of the Atlanta Public Schools,
- 4) and two laypersons

One (1) member appointed by the President of the Atlanta City Council.

Six (6) members each appointed by members of the Atlanta City Council groups:

- 1) Council Post 1At-Large and Districts 1, 2
- 2) Council Post 1At-Large and Districts 3, 4
- 3) Council Post 2At-Large and Districts 5, 6
- 4) Council Post 2At-Large and Districts 7, 8
- 5) Council Post 3At-Large and Districts 9, 10
- 6) Council Post 3At-Large and Districts 11, 12

Two (2) members appointed by the Atlanta Board of Education.

BE IT FURTHER ORDAINED THAT: that all ordinances and code sections or parts of ordinances and code sections in conflict herewith are hereby waived to the extent of any such conflict.
